# Haldia Petchem buys US firm Lummus for \$2.7 bn

aldia Petrochemicals (HPL), a flagship company of The Chatterjee Group (TCG), along with its international partner Rhone Capital has acquired US-based Lummus Technology at an enterprise value (EV) of \$2.725 billion (around ₹20,590 crore) from McDermott International.

In the joint acquisition, HPL's share is at 57 per cent, the balance would be held by Rhone Capital. Under the new dispensation, Lummus Technology would function as a 'standalone' autonomous entity. The deal was completed on Tuesday.

Lummus Technology is a master licensor of proprietary technologies in refining, petrochemicals, gas processing and coal gasification sectors, as well as a supplier of proprietary catalysts, equipment and related engineering services. It has about 130 licensed technologies and more than 3,400 patents and trademarks.

## **US slaps Glenmark** with charges of price fixing

Glenmark Pharmaceuticals, USA, was charged for conspiring to fix prices for generic drugs, the US Department of Justice said on Tuesday.

The case, filed in the US District Court in Philadelphia, Pennsylvania, involved allegation that Glenmark conspired with Apotex Corp and other generic drug companies to increase and maintain prices of pravastatin and other generic drugs beginning in or around May 2013 and continuing until at least in or around December 2015, the Department of Justice said.

The charge alleges that the gain to the conspirators, and the loss to the victims, was at least \$200 million, it added.

When asked about the charges, a Glenmark spokesperson said, "We strongly disagree with the charges being advanced by the Federal government and do not believe the evidence supports the government's case." "These charges run contrary to the verv essence of Glenmark to drive down drug prices and improve patient access to medications. We will continue to vigorously defend against these charges, and we are confident the overwhelming evidence will make that clear," the spokesperson added. Glenmark is the fifth firm to be charged over the past 13 months in connection with antitrust violations in the pharmaceutical generic industry. The previous corporate charges, including the charge against Glenmark's co-conspirator Apotex, were resolved by deferred prosecution agreement, the statement by the US Department of Justice said. 
